### HISTORICAL BACKGROUND



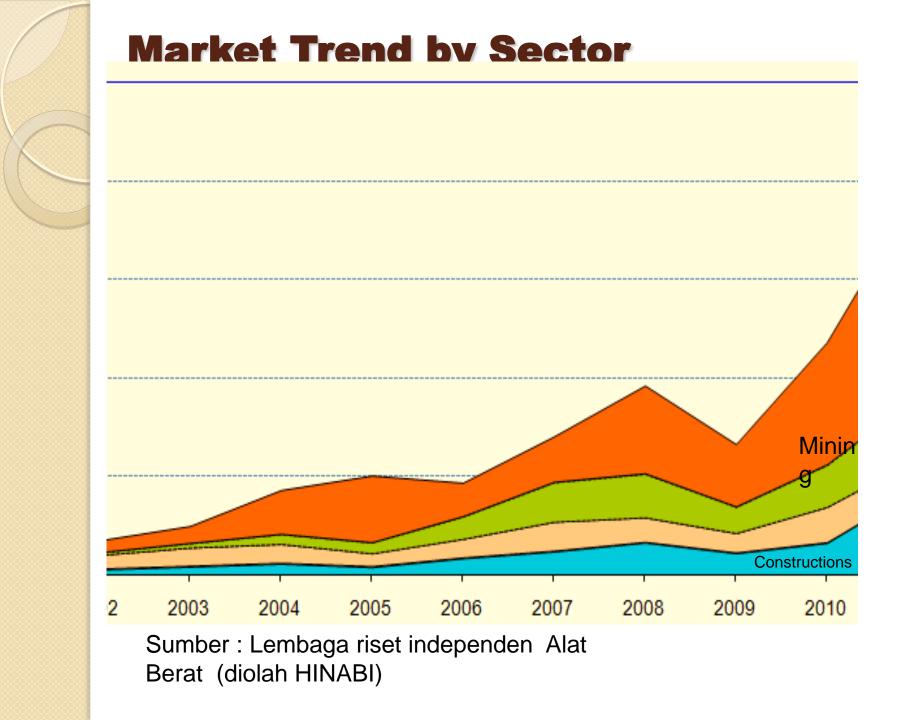
- Established in 1986 under the Supervison of Ministry of Pubic Works

## Profile of APPAKSI (1)

- A small fleet Private (Companies) Owner of Construction Equipment that provide Operating Lease
- A Large Fleet Private (Companies) Owners that both provide Operating Lease or act as Contractors
- State (Government) Owned Companies which are mainly act as Contractors.
- International Companies (PMA) which are both provides Operating Lease and or act as Contractors such as Thiess Contractors etc

## Profile of APPAKSI (2)

- 1998-1997 focusing on Government infrastructures projects, APPAKSI grew from merely 12 Founders Members to more than 269 Members
- 1998 Economic Crisis had change the face and profile of APPAKSI. Active members dropped drastically and mostly divert to Mining, Plantation and Forestry Sectors.

#### Market Share By Sector 2015 -2017 PROJECTION

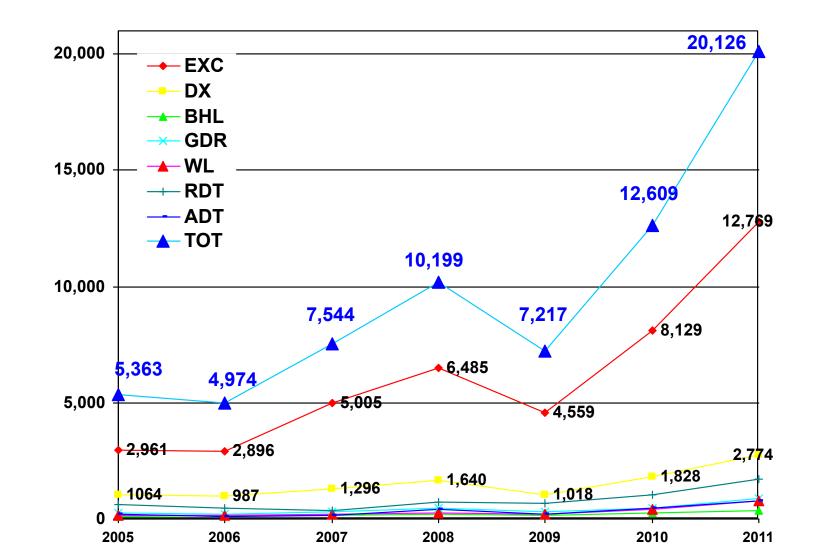

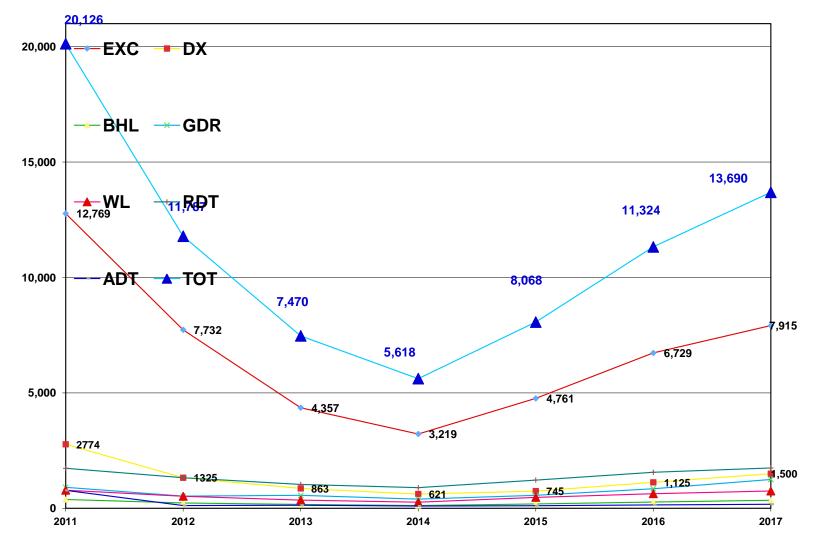


## Market Growth 2005 -2011
